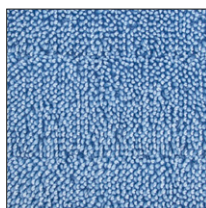

FEATURES

- Tests carried out by an independent external laboratory according to UNI EN 16615:2015 show that the mop, when used wet, can remove the bacteria Staphylococcus aureus ATCC 6538, Pseudomonas aeruginosa ATCC15442 and Enterococcus hirae ATCC 10541 with a reduction capacity of 96.6%.
- Tests by an independent external laboratory show that the mop, used wet, can remove Coronavirus 229E from steel surfaces with a reduction capacity of 99.9%.
- Thanks to a particular twisting process, this twisted yarn keeps its shape even after many washing cycles with low linting
- It removes easily the dirt without friction on the floor; high absorbing capacity thanks to its composition
- Two-hole flaps in order to grant a safer fixing of the mop to the mop holder
- Latex-free product

MATERIAL

CLEANING SIDE

Microfibre: 75%
Microfibre composition: 80% Polyester - 20% Polyamide
Microfibre Denier: 0,14
Other fibers: 25%
Fibre composition: 100% Polyester
Fabric weight: 440 gr/sqm

BACKING

Polyester

SYSTEM

Flaps in polyurethane for size 40 cm - in polyester for size 50 cm

ABSORBENCY

A dry mop absorbs up to twice its own weight

COVERING POWER

The mop can cover about:
45-50 m² in the 40 cm size
55-60 m² in the 50 cm size

LIFE CYCLE

Can be washed max 400 cycles if washing instructions and warnings are followed

CARE AND MAINTENANCE

WARNINGS

Follow carefully the washing instructions and warnings on the detergent packaging (temperature and dosing) before washing
We recommend the use of normal detergent for textiles, no fabric softener
Always a pre-wash cycle in cold water without detergent to remove any residue of chemical solution
We suggest to use the specific net bags for the mop washing

WASHING INSTRUCTIONS



SUGGESTED washing temperature: 60° C



MAX washing temperature: 95° C



Bleaching possible - Do not use chlorine or bleach



Mechanical drying at low temperature 50°C



No ironing



Do not dry clean

Do not use softener
Use alkaline detergents with Ph < 11

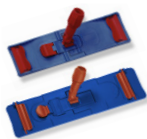

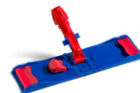
